In addition to evaluating each candidate's relative ability, as demonstrated by quality and breadth of experience, the following factors will provide the basis for competitively evaluating each candidate:

- Knowledge or professional work experience in the principles and practice of environmental, chemical, or civil engineering relating to a) water quality control and water resource management; and b) the design, construction, and evaluation of structural and non-structural best management practices, low impact development techniques and post-construction treatment control BMPs to control storm water and wastewater.
- Knowledge of physical, biological, and chemical factors relating to the control of water pollution and water quality; aquatic ecology, chemistry, biology, and statistics; and management of surface waters and groundwaters.
- Demonstrated interest in water quality control-related work consistent with the San Diego Water Board's mission.
- Knowledge of the interpretation, implementation, and enforcement of State and federal statutes, regulations, and policies, including relevant sections of the federal Clean Water Act and California Water Code, concerning storm water quality control and the National Pollutant Discharge Elimination System (NPDES) permitting program.

- Proficiency with standard office software such as Microsoft Excel, Word, and PowerPoint. GIS skills are also highly desirable.
- Ability to listen, speak, and write effectively and facilitate communication with others.
- Ability to interact with the public, solicit and respond to public comments on work products, and make effective public presentations or briefings.
- Ability to prioritize, organize, and plan work; work independently or in cross-disciplinary teams; follow instructions through standard work processes; follow through on commitments; check work products for accuracy; and meet critical deadlines.
- Ability to maintain effective working relationships with Water Board staff and outside stakeholders in a professional and courteous manner.
